## Scope of Work :-

Sl.no	Item particulars
1	Cleaning of W.C. Pan, wash basin, wall and floor tiles.
2	Providing and fixing Mirror, Flushing Cistern, PVC whaste pipe for sink and wash basin
3	Cleaning of chocked sewer line chamber and repairing.
4	Providing and fixing PVC pipe and band 110mm Dia for Sewer line
5	Providing and fixing C PVC pipe 15,20,25 MM dia PVC bib Cock, Angle cock, pillar cock, and Gate valve.
6	Providing and fixing Brass curtain Rods with Brackets, Door stopper, Tower Bolt, handle, and sliding door bolt.
7	Renewing damaged Glass Pans with putty & Nails, and renewal of old Putty of Glass pan.
8	Roof Grading of mix with (1:2:4) at top floor of building.

#### Terms and Condition :-

- 1. Work should start within 07 days from the date of work order. Liquidated damage in the sum of Rs.0.5% of the contract price for delay of work for every week will be charged.
- 2. The L1 will be decided on the basis of total cost of above mentioned works.
- 3. Contractor's name address and name of work should be mentioned on the envelop.
- 4. Validity period of the quotation should be 90 days only from the date of opening.
- 5. Work should be completed within 30 days from the date of work order.
- 6. Payment will be made after completion of the work in all respect with certification in bills from the certifying Officer.
- 7. The interested bidder may visit the site for any clarification and survey before quoting the rates.
- 8. AIIMS Deoghar reserves the right to place work order full or partially. It also reserves the right to reject or cancel the quotation without any prior information.
