Name of the work:- Repairing of Toilets, Doors and Windows, arrangement of water supply and other Misc works in OPD Building PTI Campus Deoghar.

Sealed quotations are invited from intending experienced contractor and having GST registration for the work of Repairing of Toilets, Doors and Windows, arrangement of water supply and other Misc works in OPD Building PTI Campus Deoghar as per details noted below. The Quotation, copy of GST registration and experience certificate should reach within 10 (Ten) days from the date of issue of quotation to "Administrative Officer" AIIMS Deoghar P.T.I. campus, Jashidih, Deoghar Jharkhand Pin Code 814142.

Scope of Work:-

Sl.No	Item particulars
1	Cement concrete flooring (1:2:4) 40 MM thick with 20 MM nominal size stone aggregate.
2	Providing and fixing of flush door shutters, Stainless Steel butt Hinges etc.
3	Renewing glass panes with putty and nails. Float glass panes of nominal thickness 4 MM of windows.
4	Renewal work for old putty of glass panes (length)
5	Providing and fixing of Polyethylene Water Storage Tank 2K liter
6	Providing and fixing Aluminium Doors, Windows and Ventilator with net.
7	Providing and fixing water closet squatting pan (Indian type W.C. pan with 100 MM sand cast iron P or S trap, 10 litre low level white PVC flushing cistern including flush pipe.
8	Providing and Fixing of PVC pipe Dia 15MM, 20MM and 25MM Bib cock, Angle cock and pillar cock.
9	Easing adjusting flux door shutter of easy moving including change of damaged screws and other related item.

Terms and Condition :-

1. Price should be Quoted against each item of works as per above table.
2. Price quoted should include all Taxes.
3. Work should start within 07 days from the date of work order. Liquidated damage in the sum of Rs.0.5% of the contract price for delay of work for every week will be charged.
4. The L1 will be decided on the basis of total cost of above mentioned works.
5. Contractor's name address and name of work should be mentioned on the envelop.
6. Validity period of the quotation should be 90 days only from the date of opening.
7. Work should be completed within 30 days from the date of work order.
8. The contractor should submit documentary evidence of similar level of work carried in any central Govt./central PSU Organisation in Jharkhand.
9. Payment will be made after completion of the work in all respect with certification in bills from the certifying Officer. Minimum Guarantee period of work shall be (one) year.
10. The successful bidder shall deposit 10 % PBG of work value from a nationalised bank with validity period of one year in the name of AIIMS Deoghar before awarding the work.
11. The interested bidder may visit the site for any clarification and survey before quoting the rates.
12. AIIMS Deoghar reserves the right to place purchase order full or partially. It also reserves the right to reject or cancel the quotation without any prior information.
